Whereas the Eastern Kings Fire Department required a new generator for Operations and their Reception Centre and that the Board applied for funding through the "Community Revitalization Program" and a subsequent Agreement between the Government of Prince Edward Island, as represented by the Minister of Fisheries, Tourism, Sport and Culture; and Of the First Part. Eastern Kings Fire Department, is a non-profit corporation duly registered under the laws of Prince Edward Island, with its head office at 249 Elmira Road, Rte. Souris PE C0A 2B0, Kings County, Province of PEI, in an Agreement dated 30 October 2023; and

Whereas the Agreement covers approximately 75% of the full cost of the generator and installation; and the Eastern Kings Fire Department through a Letter of request dated December 19, 2023, to the Rural Municipality of Eastern Kings Council to cover the remaining cost of the Generator as outlined below:

Be it resolved that the Rural Municipality of Eastern Kings Council agrees to provide the balance of the Generator Purchase for the operations of the Eastern Kings Fire Department Reception Centre; a total of: \$7,587.75 in one installment from the RMEK Reserve Fund Account. (See Schedule A)
